<u>Construction Certification</u>: Please call your client's attention to General Condition #4, requiring that a qualified engineer and the permittee issue certifications, at the end of construction, that the project was constructed in accordance with the approved plans and specifications.

Inspection and Maintenance (I&M) Responsibilities

Please be sure that you transmit a copy of the I&M Manual to your client. We also ask that you apprise them of their responsibilities for I&M.

Final PDF Transmittal

Now that the permit has been issued, in accordance with Env-Wq 1503.20 (e), **within 7 days** of the issuance of this permit please submit the requisite electronic copies containing copies of all approved project documents. This can be sent via email, rather than CD, if you prefer.

Before you send your PDFs check to make sure that: 1) they is not corrupt, 2) they contain the report and plans that were approved, not ones from an earlier submittal; and 3) they contain all the approved documents. If sending a CD, we'd appreciate CDs in white paper sleeves if you have them – we store them this way, so less waste.
